## What Does The Lord Require?

Have you ever wondered, what does the Lord require of me? How should I live in a society that is increasingly selfish, increasingly sinful and increasingly stupid? If so, Micah is a book you might want to consider.

The book of Micah is styled after a court case that God is bringing against Judah and centers on a verse which marvelously summarizes the lifestyle that God would like all of us to exhibit. **Micah 6:8 He has told you, O man, what is good; and what does the Lord require of you but to do justice, to love kindness, And to walk humbly with your God?**

Micah is essentially saying 'There is nothing new here. God has already told you what his requirements are' through the Law and the Prophets. Jesus quoted the sense of this verse from Micah in challenging the empty religion of His own day. In Matthew 23: 23 **"Woe to you, scribes and Pharisees, hypocrites! For you tithe mint and dill and cumin, and have neglected the weightier provisions of the law: justice and mercy and faithfulness; but these are the things you should have done without neglecting the others."** Jesus accused the Pharisees of majoring in the minors of external religious practice when He told them they had "neglected the weightier

provisions of the law: justice and mercy and faithfulness." As 21st century followers of Jesus Christ, we are folded into this set of expectations. So what does God require of us if we are going to consider ourselves His redeemed people? Micah's list of core requirements focuses on three things.

First, God requires us to do justice, or act justly. Justice describes right relationships with other people based on how God views them, treating others in a way that honors and glorifies God. It implies attitudes and behaviors that reflect God's commitment to justice. He has made those clear in the law that He gave Israel. He is concerned about the protection of foreigners and slaves, of orphans and widows, anyone who is vulnerable and can be easily taken advantage of or wronged. We are called to challenge those in authority who are using their position to take advantage of people who are weak and vulnerable. We are to defend and serve the helpless victims who live in our communities: battered women, children of poverty, immigrants among us and the unborn.

The second requirement is to love kindness or, as some translations may say, loyalty.

The Hebrew word is che'sed, which means "loyal love," which is the greatest attribute of God in the Old Testament. It defines His steadfast love. Our call is to love people in the same way that God loves us:

unconditionally, mercifully, passionately, consistently, kindly, and with loyalty. God is attentive, and faithfully loyal to us. Again, as followers of Jesus Christ, our relationships are to be marked by this kind of loyal love. Husbands and wives, cultivate this spiritual quality of loyalty in your marriage. You will be a wonderful picture of God's love. We live in a society that doesn't know much about loyalty in love relationships. Parents, cultivate loyalty with your children. Spend time with them. Invest in them. Then you will be wonderfully counter-culture in not placing your career ahead of your family. Children, cultivate loyalty with your parents. We live in a day and age where it's not cool to be loyal to your parents, where the norm is to put your parents down, and dishonor them. But the call of Micah is to go against that flow and show loving-kindness to your parents. Finally, for those in the workplace, in a culture where commitments are taken lightly and contracts are made to be broken, we are called to actively cultivate che'sed in our business relationships. The call is for us is to fulfill our obligations, to make our word our bond. That is loving-kindness.

The final requirement is to walk humbly with God; The Hebrew root of the word

describes a lifestyle that is not proud, not self-willed, and not arrogant. We are called to walk in submission to God and to His heart, His will, and His ways. We are to live attentively and carefully. We are to follow God's will prudently. Learning to walk humbly with God frees us to do justice and cultivate loyal relationships with the people around us.

There are times when we want to bargain with God about His requirements of us. We tend to trust external religious activity. We stay busy doing religious things rather than sustaining pro-active justice, loyal relationships, and a submissive walk with God. We'd rather do it our own way than listen to God. If we are honest, we know we are prone to wander from resting in the Lord and towards restless striving, trusting our own resources, and eating the bread of anxious toil and tasting futility. If we are honest, we have to recognize that we are no better than the people of Judah.

The good news is these are the only kind of people God saves, those who know they are lost. The only kind of people God forgives are those who know they are guilty. If we see ourselves as God sees us, then we can, by faith, become what He wants us to become. True saving faith comes from a heart that has been broken in repentance and realizes that only God can atone for sin; we can't atone for our own sin.

If you are worried about going to court with God remember what John said, **"My little children, I am writing these things to you that you may not sin. And if anyone sins, we have an Advocate with the Father, Jesus Christ the righteous; and He Himself is the propitiation for our sins; and not for ours only, but also for those of the whole world."** (1John 2:1-2) We have a lawyer and His name is Jesus. The same Jesus who can represent you in God's courtroom is the same Jesus who can help you to be the kind of person He wants you to be. Ask Him and trust that He will help you.
